Inhalation of dust may have the following serious chronic health effects: Excessive inhalation of respirable dust can cause pneumoconiosis, a respiratory disease, which can result in delayed, progressive, disabling and sometimes fatal lung injury. Symptoms include: loss of memory, loss of intellectual ability and loss of coordination. Intentional misuse by deliberately concentrating and inhaling the contents may be harmful or fatal. Overexposure or misuse of toluene can cause liver, kidney, and brain damage as well as cardiac abnormalities. There have been cases of aplastic anemia from toluene in industrial exposures (ACGIH, 1992). Increased coagulation time and reduced clotting factors have also been found, which are indicators of damage to the bone marrow (Clayton & Clayton, 1994). Symptoms include: loss of memory, loss of intellectual ability and loss of coordination. Constituents of this product include crystalline silica which, if inhalable, may cause silicosis, a form of progressive pulmonary fibrosis. Inhalable crystalline silica is listed by IARC as a group I carcinogen (lung) based on sufficient evidence in occupationally exposed humans and sufficient evidence in animals. Crystalline silica is also listed by the NTP as a known human carcinogen. Constituents may also contain asbestiform or non-asbestiform tremolite or other silicates as impurities, and above de minimus exposure to these impurities in inhalable form may be carcinogenic or cause other serious lung problems.
